## **NAUGATUCK DOG PARK RULES**

**USE THE PARK AT YOUR OWN RISK.**

**BE KIND TO ONE ANOTHER**

**NO ILL OR AGGRESSIVE DOGS**

**DOGS MUST BE AT LEAST 4 MONTHS OLD.**

**RABIES VACCINATED. (proof is a valid DOG LICENSE).**

**A VALID DOG LICENSE. (\$75 FINE)**

### **Sec. 22-341. Tag or plate to be attached to dog collar or harness. Cost.**

(a) Each owner or keeper of a licensed dog shall keep around its neck or body a collar or harness of leather or other suitable material, to which shall be securely attached a tag or plate issued to such person by the town clerk. If any such tag or plate is lost, the owner or keeper of such dog shall forthwith secure a substitute tag or plate from the town clerk, at a cost of fifty cents.

(b) The town clerk of each town shall order a sufficient number of such tags or plates from the commissioner, who shall furnish the same at a cost of five cents each, which cost shall be paid by the town on the approval of the town clerk. Any balance of the moneys received by the commissioner after deducting the cost of the tags, the expenses incidental to their distribution to the town clerks and the expenses incidental to the enforcement of the provisions of this chapter, shall be accounted for by the commissioner to the Comptroller. The design and the shape of such tags or plates shall be changed each year, and such tags or plates for each year shall be of uniform design and material throughout the state. Any dog found roaming at large upon any public highway or common or upon the premises of any person other than its owner, without a tag as provided in this section, shall be presumed to be an unlicensed dog.

## ***NAUGATUCK DOG PARK RULES***

**NO SMOKING NO ALCOHOLIC BEVERAGES IN THE PARK.**

**PARK CLOSSES AT DUSK.**

DOGS MUST BE ACCOMPANIED BY AND UNDER THE CONTROL OF THEIR HANDLER AT ALL TIMES.

PLEASE UNLEASH YOUR DOGS IMMEDIATELY WHEN ENTERING THE PARK. (Leashed dogs may feel threatened when off leash dogs greet them.)

NO PRONG, SHOCK, SPIKED OR CHOKE COLLARS ALLOWED. These are for training only and not for play time.

PLEASE CARRY A LEASH AT ALL TIMES (No longer than 6 feet is suggested.)

Children under 12 must be accompanied by an adult. Parents are strictly liable for the actions of their children. PLEASE DO NOT ALLOW CHILDREN TO RUN IN THE PARK.

**PLEASE USE THE SMALL DOG AREA FOR YOUR SMALL OR TIMID DOG.**

However, **small dogs are allowed in the large dog area** if they're very brave.

PLEASE CLEAN UP AFTER YOUR DOG. Also, it would be kind to pick up anything other dogs owners forgot about.

NO MORE THAN TWO DOGS PER PERSON.

NO HUMAN FOOD ALLOWED IN THE PARK.

If you bring a treat for your dog, please have them in sealed containers.

PLEASE NO GLASS CONTAINERS OR BOTTLES.

KEEP YOUR DOG IN SIGHT AND UNDER YOUR CONTROL AT ALL TIMES.

DON'T BRING A FEMALE DOG IN HEAT.

PLEASE FILL IN HOLES AND REPAIR ANY DAMAGE CAUSED BY YOUR DOG.

## **NAUGATUCK DOG PARK RULES**

PLEASE DO NOT BRING IN KIDDY POOLS OR ANY LARGE OBJECT THAT CAN HOLD WATER.

DO NOT BRING PETS OTHER THAN DOGS. (That means no gerbils, kangaroos, etc.)

PLEASE BE SURE THE GATES ARE CLOSED WHEN COMING INTO OR OUT OF THE ENTRANCE.

NO BICYCLES, SKATEBOARD, ROLLER BLADES, SPACESHIPS OR DRONES.
